- The Department of Labor is doing some work to reduce or eliminate the availability of subminimum wage jobs. In Cincinnati, there are still ~200 people who work a job with subminimum wage. OOD working on providing paid mentors, featuring people with IDD who will provide mentorship and guidance to those in that type of employment. 4. Policy Updates

- **Federal Update:** The Home and Community-Based Services (HCBS) Relief Act of 2023 was introduced in Congress by Senator Bob Casey (D-PA). The bill would provide two years of additional Medicaid funds to:
 - Improve access to HCBS by increasing direct care worker pay and benefits;
 - Decrease the number of people on waiting lists for HCBS (currently over 650,000!); and
 - Pay for assistive technologies, staffing, and other costs that facilitate community integration.
